3. Request approval of a Resolution adopting the Attainable Workforce Housing Performance Grant Program Policy presented by Senior City Attorney Alex Stiles.

Presentation: Senior City Attorney Alex Stiles presented a request to adopt a resolution approving the Attainable Workforce Housing Performance Grant Program Policy. Mr. Stiles provided the reminder that this policy was reviewed at the March 11, 2025 Virginia Beach Development Authority meeting and had since been adopted by City Council on April 1, 2025.

Discussion: Chair Lisa Murphy asked about the process of approval for this grant. Mr. Stiles noted that Council and the VBDA would both review the scope and requested tax incentive. This grant is revenue neutral to the Authority, as funds would be provided by City Council to the Authority to fund any approved grants.

4. Request approval of granting additional property owner use of an existing private utility easement on VBDA property: Princess Anne Hunt Club presented by Senior City Attorney Alex Stiles.

Presentation: Senior City Attorney Alex Stiles shared information on an Authority-owned parcel with an existing sewer easement that serves several surrounding properties. The request is to add the existing neighboring parcel to the easement. This would be no additional burden on the Authority's property.

FACADE IMPROVEMENT GRANT PROGRAM (FIG)

5. Request approval of a Resolution approving 11 grants in the amount of \$65,906 under the FIG Program presented by Town Center Planning Coordinator, Roosevelt Grandberry *Presentation:* Town Center Planning Coordinator, Roosevelt Grandberry, presented 11 businesses that have been recommended by the FIG Review Committee for the Façade Improvement Grant, a program that provides support to small, locally owned & operated businesses located in any commercial or industrial zoned area within the City of Virginia Beach.

The FIG program provides grants for impactful exterior building or site improvements. Funding for this fiscal year opened with \$111,127, with a minimum award of \$1,000 and a maximum award of \$10,000, with 9 awards granted by the Authority in March 2025. The requested remaining total amount of funding for the awards considered today is \$65,444, with an estimated private investment of \$138,988. These awards will exhaust the 2025 Façade improvement grant fund.

Discussion: Commissioner Esmel Meeks asked for the FIG ranking system to be explained. Mr. Grandberry shared that the ranking system has eligible businesses and eligible project markers. Commissioner Akhil Jain asked how many applicants do not meet the criteria. Mr. Grandberry shared that for 2025, only 5 of the total 25 applicants didn't meet requirements. Vice Mayor Rosemary Wilson added to the conversation by stating that, should the proposed City budget be passed, there will be additional funds created for Façade Improvement Grants specifically along Atlantic Avenue. She noted that a task force will be established to create recommendations for the improvement of Atlantic Avenue.

Presentation: Business Development Representative I, Dominique DeBose, presented a request for an award of \$162,681 EDIP Grant pursuant to Part A to Neptune SHIELD Holdings LLC. A company that supports special operations and veterans looking for private office spaces, consulting and mentorship, and other amenities such as a secure space known as a SCIF.

INTERNATIONAL INCUBATOR

7. Request approval of a Resolution authorizing a sublease in the International Incubator to RVT Group, presented by Business Attraction Coordinator, Paige Fox

Presentation: Business Attraction Coordinator, Paige Fox, presented information on RVT Group, a UK company that specializes in temporary ventilation systems used across multiple sectors. Ms. Fox gave a reminder that the International Incubator was created to serve as a soft-landing spot for international companies coming to the region and looking to establish a foothold in Virginia Beach. Ms. Fox also shared images of the recent international incubator upgrades.

Discussion: Chair Murphy asked Ms. Fox to share additional details on AUKUS and why there is so much local interest in defense and shipbuilding in our area. Ms. Fox noted that in simple terms, AUKUS is a collaboration between Australia, the UK, and the US to increase shipbuilding capabilities. Hamptons Roads is home to the nuclear aircraft carrier shipbuilding facility. Ms. Fox projects additional growth in those sectors.

The lease would be a new proposed "membership" structure where companies can utilize shared spaces and have a US mailing address but not maintain a private office.
